Singles:

All events are RR to SE. 4 players per Round Robin group. Both Rated and Unrated players will be permitted to advance from Round Robin groups to Single Elimination finals.

Prizes:

Matches must be played for prize money and trophy's to be awarded.

Tournament Director:

Has the right to expand events as time and tables allow, approve unrated players before entry into rated events or modify any event or format for insufficient or over participation.

Deadline: Cancellations prior to March 30th, will be refunded, "no shows" will not be refunded. Events may be canceled for insufficient entries and fees refunded.
